Residents of U.S. states and the District of Columbia traveling to Costa Rica must secure and show proof of an active travel insurance program, which includes:

- Up to \$50,000 USD of Medical Expense Coverage
- Up to \$2,000 USD Accommodation/Lodging Coverage
